Scope and Content Note

The papers of the Carroll family span the years 1684-1838 and consist of letters, deeds, bills, accounts, and account books (1684-1771) of Charles Carroll of Annapolis, Maryland. Other papers include correspondence (1767-1829) addressed chiefly to William Gibbons, overseer; legal papers (1814, 1830-1832); financial papers (1785-1832); and family portraits of Charles Carroll of Carrollton, Maryland.
