Scope and Content Note

The papers of Anne Brock Turpeau (1924-1913) span the years 1915-1986, with the bulk of the material concentrated in the period 1960-1986. The collection includes correspondence and memoranda, appointment calendars and notebooks, family and biographical records, speeches, writings, organizational minutes and agenda, studies, project proposals, conference and committee records, legal documents, reports, press releases and statements, newspaper clippings, and other printed matter relating to Turpeau's public service career and activism on behalf of women's rights, civil rights, and community development. The papers are arranged in three series: Professional File, Organizations File, and Miscellany.

The <u>Professional File</u> documents Turpeau's employment, political appointments, private consultancies, and public speaking and writing career. Files from her early work in public relations, teaching, and contract writing serve as a background to her later administrative positions. Turpeau worked with the Washington Urban League in Washington, D.C., from 1965 to 1972. Papers from her tenure as Neighborhood Development Center director and later as associate director of the Washington office feature urban renewal projects, housing assistance, job training, crime prevention, and the legal battle over utility company deposits. In the mid-1970s, the emphasis of Turpeau's work shifted to women's rights. Her service as chair of the District of Columbia Commission on Women is documented in this series, along with her work as chair of the District of Columbia International Women's Year (IWY) Coordinating Committee. The IWY Coordinating Committee was responsible for holding a "state" meeting to elect representatives to the 1977 National Conference on Women in Houston, Texas, and to draft a local plan of action. Turpeau was elected head of the D.C. delegation and records of its participation in the National Conference for Women are included with other IWY Coordinating Committee records. Her appointment calendars and notebooks concern aspects of daily work, but also include sporadic notes on conferences and meetings or for letters, speeches, and writings.

The <u>Organizations File</u> documents Turpeau's numerous associations with civic and professional groups, especially during the 1970s and 1980s. Her organizational work is most often related to women's issues and women's rights initiatives. She was a founding member of the Organization of Black Activist Women and the Washington Women's Forum and a charter member of the Black Women's Agenda. Records for these organizations are included in this series.

Much of Turpeau's work on women's issues revolved around the United Nations Decade for Women, 1975-1985. Earliest documentation related to the United Nations Decade for Women is found in records from the National Council of Negro Women (NCNW) in the Organizations File. Turpeau worked with the NCNW to develop seminars for an international group who met to discuss problems faced by women in economically undeveloped areas of the world, including a panel discussion at the first United Nations Conference on Women in Mexico City in 1975. After the 1977 National Women's Conference, Turpeau was elected cochair of a Continuing Committee, the group established to promote the conference's national plan of action to improve the status of women. Records from the Continuing Committee of the Nation Women's Conference document Turpeau's most extensive work with a national women's organization. As cochair, Turpeau was appointed to the United States delegation to the 1980 United Nations Decade for Women World Conference in Copenhagen. Files relate to Turpeau's work with the United States Secretariat in preliminary regional conferences and as an active member of the Copenhagen delegation. Her appointment calendars and notebooks for 1980 in the Professional File also contain many references to the Copenhagen conference. Turpeau attended the closing meetings of the conference in Nairobi, 1985, as a private citizen. Files for this meeting are less extensive.

The <u>Miscellany</u> series contains scattered personal and family records along with a few topical files. The personal papers provide an indication of the achievements and history of the Brock and Turpeau families. Ann Turpeau's parents, both of whom were graduated from colleges in Georgia, were on the faculty of West Virginia State College in Institute, West Virginia. Her father, George Brock, was a graduate of Morehouse College, and her mother, Anne Blocker, was a Spelman College alumna. The Turpeau family migrated from Louisiana to Cincinnati, Ohio, where her father-in-law, David Dewitt Turpeau, was a distinguished Methodist minister and five-term Republican state senator.
