## **Scope and Content Note**

The papers of Charles P. Summerall (1867-1955) span the years 1880-1955, with the bulk of the material from 1917 to 1919. The collection consists of general and personal correspondence, reports, speeches, writings, photographs, maps and charts, clippings, field orders, and miscellaneous material. The papers are organized into ten series: <a href="Diaries">Diaries</a>, Notebooks, and Engagement Books; Correspondence and Memoranda; Orders, Decorations, and Citations; Commands and Duties; Subject File; Speech and Article File; Photographs; Clippings; Miscellany; and Oversize.

The field orders in the collection cover Summerall's military career from the time he graduated from the United States Military Academy at West Point in 1892 until he retired from the army in 1931. Professional correspondence of this period does not appear in the papers, except for the World War I years. The correspondence includes letters concerning his months of retirement in Eustis, Florida, in 1931; a movement in Florida to draft him as a candidate for governor or representative-at-large, 1931-1932; and some, from 1931 to 1940, relate to his activities as president of the Citadel in Charleston, South Carolina.

The bulk of the material deals with Summerall's commands during World War I as field commander of the First Division and other units in the American Expeditionary Forces in France. Correspondents include Generals Robert Lee Bullard, Frank Parker, Albert Jesse Bowley, Hugh Aloysius Drum, James G. Harbord, John J. Pershing, and Douglas MacArthur; French Generals Henri Philippe Pétain and Charles A. Vandenburg; Senators Arthur Capper and Duncan Upshaw Fletcher; and others such as Newton Diehl Baker, Theodore Roosevelt, Robert Rutherford McCormick, and Patrick J. Hurley.

Memorabilia and other items in the <u>Miscellany</u> series include letters from William T. Sherman, 1880, and George Henry Preble, 1881, addressed to David Taylor Morgan.
