Summary: Chiefly transcriptions and copies of documents in foreign archives and personal collections relating to the history of the United States, especially the early Spanish period and British ministers to the United States from 1791 to 1812, collected for publication projects of the Carnegie Institution of Washington.

Provenance

The Carnegie Institution of Washington gave the Reproductions Collection to the Library of Congress in 1935. It consisted of transcriptions of documents related to British ministers to the United States from 1791-1806. Transcriptions of documents and notes from other printing projects, including *Instructions to the British Ministers to the United States, 1791-1812*, by Bernard Mayo (Washington, D.C., 1941) and *Descriptive Catalogue of the Documents relating to the History of the United States in the Papeles Procedentes de Cuba deposited in the Archivo General de Indias at Seville*, by Roscoe R. Hill (Washington, D.C., 1916), were added as a gift in 1941. Some items received with this collection were transferred to other Manuscript Division collections of reproductions from British repositories as part of the division's Foreign Copying Program.

Processing History

The records of Carnegie Institution of Washington were arranged and described in 1990. The finding aid was revised in 2011.

Copyright Status

The status of copyright in the unpublished writings of Carnegie Institution of Washington is governed by the Copyright Law of the United States (Title 17, U.S.C.).

Access and Restrictions

The records of Carnegie Institution of Washington are open to research. Researchers are advised to contact the Manuscript Reading Room prior to visiting. Many collections are stored off-site and advance notice is needed to retrieve these items for research use.

Scope and Content Note

The papers in the Carnegie Institution of Washington Reproductions Collection span the years 1686-1941, with the bulk of the items dated from 1686 to 1812. The transcriptions and copies of documents relating to the history of the United States, especially the early Spanish period and British ministers to the United States from 1791-1812, were collected for publication projects of the Carnegie Institution of Washington. Two of the publications were *Descriptive Catalogue of the Documents relating to the History of the United States in the Papeles Procedentes de Cuba deposited in the Archivo General de Indias at Seville*, by Roscoe R. Hill (Washington, D.C., 1916) and *Instructions to the British Ministers to the United States, 1791-1812*, by Bernard Mayo (Washington, D.C., 1941). The material was chiefly copied from the British Foreign Office and Public Record Office, archives in the Netherlands and Scandinavian countries, and from the Archivo General de Indias in Seville, Spain. Included also in the collection are the notes of Carnegie Institution of Washington members Reuben Gold Thwaites and Francis S. Philbrick, and material relating to John White (fl. 1585-1593), the first English artist to visit American, and John C. Calhoun. Subjects also include European treaties and Yucatan.

Arrangement of the Papers

The collection is organized largely as received by type of project or material. Some items were <u>transferred</u> from these papers to other collections of British material in the Manuscript Division
